Adoption of a Resolution in Support of an Independent International Investigation into the Disappearance of Forty Three Students from

Iguala Guerrero Mexico

SUMMARY

Recommendation – That the City Council adopt the attached Resolution in support of a full investigation into the disappearance of students from Iguala Guerrero Mexico.

Fiscal Impact – None with this action.

Previous Council Action – At their Meeting on November 17, 2014, the Council directed that this matter be placed on the next Agenda for consideration after several speakers spoke on the matter and presented a draft resolution.

EXECUTIVE SUMMARY

The Mexican-American community plays an important role in the social, cultural and economic landscape of the City of Pomona. On September 26, 2014 in the Mexican City of Iguala Guerrero forty three students from the Ayotzinapa Rural University were taken by force and are still missing as of the drafting of this report. The senseless disappearance of these students and other human rights violations in Iguala, Guerrero Mexico have concerned Mexican-Americans and the international community as a whole. The attached resolution will assert the City of Pomona's support for conducting a full, independent international investigation into the disappearance of these students to ensure that potential human rights violations within Iguala, Guerrero, Mexico are not ignored. The language contained in the proposed Resolution has been taken directly from the draft submitted by the requesting speakers and has only been edited to fit the City's standard Resolution formatting.

RESOLUTION NO. 2014 -

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POMONA, CALIFORNIA, IN SUPPORT OF A FULL INVESTIGATION INTO THE DISAPPEARANCE OF FORTY THREE STUDENTS FROM IGUALA, GUERRERO, MEXICO

WHEREAS, on September 26, 2014, in the Mexican City of Iguala, Guerrero, forty three students from the Ayotzinapa Rural University (Escuela Normal) were taken by force and are still missing; and,

WHEREAS, the students were mostly children from poor, rural families who were training to become teachers to serve the rural and indigenous poor; and,

WHEREAS, the authorities failed to promptly and diligently take action and did not start to search for the missing students and adequately protect the survivors and the families without delay; and,

WHEREAS, the recent events in Guerrero represent an unprecedented level of human rights violations and expose extremely serious issues of impunity, collusion between police officers and organized crime gangs and excessive use of force and therefore must be addressed for remedial action; and,

WHEREAS, this incident reverberates with the experience of many Pomona residents whose families have suffered similar violence in Latin America;

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Pomona as follows:

SECTION 1. That the City Council of the City of Pomona, State of California, formally supports the breaved relatives', students' and public's demand for an independent interntational inquiry into the events that happended in Iguala, inclduing a full investigation into the disappearances, and exhaustive establishment of all responsibilities and the prosecution and effective condemnation of the responsible at levels, in line with international standards of justice.

<u>SECTION 2.</u> That the City of Pomona authorizes its council and city staff to communicate its support of this legislation and direct the City Clerk to send this Resolution to the President of the United States, the Speaker of the United States House of Representatives, the President of the United States Senate and the Honorable Members of the United States Congress representing the City of Pomona and surrounding regions.

<u>SECTION 3</u>. That the City Clerk shall certify to the approval and adoption of this resolution.
